3. The disc jockey will arrive a minimum of 20 minutes before the scheduled starting time to set up unless otherwise instructed, and will work continuously until the ending time on the date of the event.

5. It is our policy that our Disc Jockeys do not consume alcohol during the event, nor will they have consumed any alcohol before the event.
6. All final cheques will be payable to the DJ (Cash is also acceptable).
7. All special instructions of the Disc Jockey, or any special song requests will be expressed to Digital DJs a minimum of one week before the event. If no special instructions have been given, the disc jockey will use their own discretion.
