- 2. You may cancel your booking at any time; however, you will forfeit the deposit if the booking is cancelled.
- 3. The disc jockey will arrive a minimum of 30 minutes before the scheduled starting time to set up unless otherwise instructed and will work continuously until the ending time on the date of the event. Tear-down usually takes 30 minutes to complete.
- 4. Digital DJs is not responsible for the outcome of the event and does not guarantee any certain level of enjoyment by any or all attendees.
- 5. It is our policy that our Disc Jockeys do not consume alcohol during the event, nor will they have consumed any alcohol before the event.
- 6. Final payment is due on or before the date of the event.
- 7. All special instructions of the Disc Jockey, or any special song requests will be expressed to Digital DJs a minimum of one week before the event. If no special instructions have been given, the disc jockey will use their own discretion.
- 8. Digital DJs will contact the contract person one week before the date of the event to confirm all the details and get last-minute instruction.
